About Friendship House

In 2017, Friendship House Fayetteville was established through the generosity of multiple community partners and donors. Today, Friendship House is a thriving, intentional living community, where Friend and Student residents live as roommates. Friendship House is the anchor in a community of fellowship and integrated community living where individuals who have developmental and intellectual disabilities learn the skills needed to live independently.

Employment Source, a local 501(c)(3) not-for-profit that is an affiliate of ServiceSource, supports the skill building necessary for independent living. Programs that offer intentional supports in vocational, recreational and community settings empower individuals for success.

Friendship House provides the transitional, safe living space where individuals have the support needed to learn these skills.

Friendship House Cottages

As Friend residents become more independent and learn valuable skills through the transitional setting at Friendship House, there is a need for more long-term independent living. Friendship House Cottages provide additional options for the second phase of more long-term housing.



Donor Support Needed

With support from donors and partners, Employment Source is constructing Friendship House Cottages.

Donated land at the corner of Broadfoot Avenue and Branson Street in Fayetteville is home to Friendship House Cottages. Through generous donations and investment from Employment Source, construction on the first two, of potentially eight, cottages is underway effective in the summer of 2024.




